Purpose of the Position

The Head of Music Performance will take responsibility for the planning and organisation of the Instrumental Music Program, the College Instrumental and Choral Ensembles, and the Senior and Junior College Bands. The Head of Music Performance will also work towards the creation of a Music Support Group. The Catholic values of the College must always be at the forefront of planning and leading within the Musical Performance area. The Head of Music Performance is responsible for the overall vision, promotion and celebration of musical performance aspects of all College events. They will coordinate any music co-curricular programs, activities, displays, performances, assemblies and liturgies that showcase the musical performance and achievements of students and staff.

Responsibilities

- Actively support the liturgical life of the College.
- Coordinate and promote the Instrumental Music Program with instrumental teachers and external providers.
- Communicate with students, parents and instrumental teachers to promote and run the Instrumental Music Program.
- Oversee the budget of the program.
- In conjunction with the Deputy Principal Staff and Operations, develop the timetable and schedule for instrumental music staff and students, including ensembles and other musical performers.
- In conjunction with the Deputy Principal Staff and Operations, organise contracts and terms of employment for instrumental music staff, including payment arrangements.
- Maintain an attendance register for all instrumental music lessons.
- Oversee the musical direction of the annual College Production.
- Be responsible for overseeing performances, music and singing at College events, such as masses, assemblies, information nights and the end of year Presentation evening.
- In conjunction with the Performing Arts Centre and Events Coordinator provide opportunities for students to showcase performances at College events.
- In conjunction with the Performing Arts Centre and Events Coordinator, oversee the student lunchtime rehearsals and musical performances.

- Organise lunch time music room supervision roster.
- In conjunction with the College Faith and Mission Team, plan, prepare, select and rehearse celebratory and liturgical music.
- Communicate and promote College music performance events to key stakeholders and continually update the performance and events dates in the College calendar.
- Oversee the direction of rehearsals and performances for ensembles, bands and choirs.
- Provide a highly accomplished level of music at College events.
- Maintain all College instruments and musical equipment, including upkeep arrangements.
- Liaise with parents, students and the College community regarding the Music Programs.
- Other duties as assigned by the Principal.
